





South elevation - Option A







75mm square manifests, positioned in 2 rows to comply with building regulations.


Co-op Logo

Printed vinyl to be positioned in close proximity to the opening hours graphic.


Note – Automatic door arrow signage used on doors with full glass panel.







Welcome wall

Principle


To be used wherever possible. Installation in an area close to store entrance, in a spot where it would be most visible, preferably to an aisle end. Where possible, it should also be visible externally.

Specification

Dimensions as per standard detail drawing. Aperture to suit a 75" screen to allow for flush mounting. Illuminated welcome message to be mounted above the screen. Data and power to be accessed via discrete service door on side.

Colours & Finishes


Front, rear and sides of construction in EECS corporate green. Trimmed edges and corner protection strips to match. Plinths in grey. Recess in matt black to hide cabling.



Welcome wall in-store location








Welcome wall mockup

Principle

This is installed above the bank of machines which make up a stores "food to go" offering. The layout, number and type of machines on offer will vary store to store.


Specification

Minimum height 300mm, Maximum 400mm. Illuminated flex LEDs on acrylic carrier panels. Fixed proud of the wall with stand off's.

Colours & Finishes

Cool white neon-flex LED with coloured led in iconography.

Beer and wine

Principle

Section headers with iconography, only used in larger stores with visible site lines from the entrance.

Specification

Minimum height 300mm, Maximum 400mm. Illuminated flex LEDs on acrylic carrier panels. Fixed proud of the wall with stand off's.

Colours & Finishes

Coloured flex LED. Clear acrylic carrier panels.

Principle

Section headers with iconography, only used in larger stores with visible site lines from the entrance.

Specification

Minimum height 300mm, Maximum 400mm. Illuminated flex LEDs on acrylic carrier panels. Fixed proud of the wall with stand off's.

Colours & Finishes

Coloured flex LED. Clear acrylic carrier panels.

Pay here

Principle

Section headers with iconography, only used when self service machines are positioned against a wall. Do not use when against a window.

Specification

Minimum height 300mm, Maximum 400mm. Illuminated flex LEDs on acrylic carrier panels. Fixed proud of the wall with stand off's.

Colours & Finishes

Coloured flex LED. Clear acrylic carrier panels.






Frozen treats







Community board

Principle

To be present in every store for community notices. Installation in area as close to store entrance as possible, internally or externally, or within a highly visible area that is prominent.

Specification

Site specific choice of: 610mm x 915mm 915mm x 1220mm 1220mm x 1830mm

Can be installed landscape or portrait.

Header size to suit can be installed on or above.







Fixture ends

Always installed on doors to back of house areas.







Main copy set in Multiple Sans Bold in sentence case. Copy must be no less than 36mm in height, as specified in the legal requirements.

Principle


Mandatory notices to be applied to cigarette gantry. Must be displayed in a prominent position and conform with font requirements (the characters must be no less than 36mm in height).

Specification

390mm x 550mm (Portrait) Tobacco age notice 600mm x 350mm (Landscape) Tobacco age notice 72mm x 105mm age check decal

Colour & finishes

Printed vinyl decals.


